## Eden Autism Opens Center in Plainsboro Plaza

**E**den Autism officially opened its doors to its second facility in Plainsboro on August 15th. Eden families, staff, trustees, participants and community members commemorated the event, and Mayor Peter Cantu presented Eden with a proclamation to mark the occasion. "The township wishes to recognize Eden Autism not only for providing these important services to the many families and individuals in and around the Plainsboro community, but also for the recognition of the continued and developing needs of aging autistic people and for being a caring and wonderful organization," said Mayor Cantu.

The Eden families and staff had a dream to create a center that would address the unique needs of aging adults with autism. After years of designing and developing a program that is among the first of its kind, that dream officially became a reality with the opening of its Schalks Crossing Day Center in Plainsboro Plaza. The new center is specifically designed for adults who are transitioning to retirement age, are ready for retirement, or have significant medical needs.

Despite an aging population, just two percent of autism and aging research is focused on seniors with autism. With little research and programming in place, many families are left facing an uncertain future as their loved one transitions to their

senior years. This center was developed to provide stability and security for older participants and their families.

Every aspect of the center was designed with the participants in mind, allowing them to stay active within the community by walking to multiple shops and restaurants. The center has plenty of natural light and open space for participants to enjoy a wide range of activities including arts and crafts, exercise, computer skills and cooking. Nursing services, speech therapy, and clinical support are available at the new center.

## Did You Know?

***Did you know that Plainsboro-Cranbury Municipal Court has a new Court Administrator?*** Danielle Tanzi was appointed Municipal Court Administrator upon the retirement of former Court Administrator Sue Slavicek. Sue retired at the end of July, having served as Plainsboro-Cranbury Municipal Court Administrator for 15 years.

Danielle joined Plainsboro in 2017 as Deputy Court Administrator. Danielle has also served in Helmetta Municipal Court and Jamesburg Municipal Court and holds a Bachelor of Arts in Social Studies and Elementary Education from Caldwell College.

***Did you know that according to the National Fire Protection Association nearly half of all home heating fires occur during the months of December, January and February?*** The leading factor contributing to ignition for home heating fire deaths is the placement of flammable items (upholstered furniture, clothing, mattresses and bedding) too close to heating equipment.

In fact, most home heating fire deaths (86%) involved stationary or portable space heaters. It is recommended to keep space heaters a minimum of three feet away from combustible materials and to place them on a flat, level surface. Prior to

use, make sure your space heater is safety certified and always inspect the cord to be sure it is not damaged or frayed in any way. Don't forget to turn the unit off prior to leaving the room or falling asleep.

"People often think a fire is unlikely to occur within their home, but statistics indicate otherwise", stated Township Committeeman Ed Yates. "We want to remind our residents to follow these simple fire safety tips."

***Did you know that PSE&G issued a news release on its website regarding fraudulent claims by unscrupulous people trying to scam its customers?*** PSE&G advises never to give out personal financial information over the phone, instead ask for a phone number to call them back. ***Did you know that caring for more than five children in your home is considered to be operating a Child Care Center by the State of New Jersey?*** Those caring for a minimum of six children are required to be licensed by the State of New Jersey. In addition, according to township regulations, this activity must be approved by the Plainsboro Township Planning Board in residential areas.

## Adult Mental Health First Aid Course Offered

**M**ental Health First Aid is an 8-hour course that teaches you how to help someone who is developing a mental health problem or experiencing a mental health crisis. The training helps you identify, understand, and respond to signs of addictions and mental illnesses.

The adult Mental Health First Aid course is appropriate for anyone age 18 and older who wants to learn how to help a person who may be experiencing a mental health-related crisis or problem.

Participants will learn to be prepared when a mental health crisis happens and know what to do. Mental illnesses are common; 1 in 5 adults can be affected in any given year. "People with mental illnesses often suffer alone. You can be there for a friend, family member or colleague", stated Township Committee member Nuran Nabi.

## Youth Advisory Council Hosts 'Elsie the Cow' Event

**T**he Wicoff House Museum's Youth Advisory Council (YAC) hosted their first event at the museum in August, and it was a great success! The event was a celebration of the 80th anniversary of Plainsboro's own Elsie the Cow's debut at the 1939 New York World's Fair. About 700 Plainsboro area residents attended the event to learn the history of Elsie and Walker-Gordon Farms through a temporary museum exhibit and an oral history interview of Edith Perrine Sprague, who was one of two local young women known as the Flying Milkmaids who traveled the country with Elsie. Children at the event also played carnival games, made souvenirs and completed a scavenger hunt throughout the museum. Representatives from the Borden Dairy Company traveled from Texas to attend the event!

The museum's Youth Advisory Council is made up of students ages 12-18 from local middle and high schools who are interested in having an integral role in the development of the museum as a living historic resource. In addition to event planning and organizational development, the YAC assists with archive organization and research, oral history interviews and historic preservation advocacy. In the upcoming year members of the YAC will be participating in a county-wide study of history organizations, which will result in an exhibit, presentation and a report that will be submitted for publication in peer-reviewed history journals.

# Understanding Plainsboro's Snow Removal Practices

The township's main objective during a winter storm is to effectively and efficiently clear the roads of snow and/or ice. Completing this objective requires the removal of snow and ice from primary roads before entering secondary residential neighborhoods. Standard practice for most storms is to pretreat the roads then begin plowing at approximately three inches. However, since each storm is unique Plainsboro alters its operations to meet the immediate needs of the current storm.

Plainsboro's roads are divided into two types: primary roads and residential secondary roads. Primary roads provide access through Plainsboro, are heavily travelled and connect the town's neighborhoods and commercial areas. Secondary residential roads provide access within their subdivisions. The exceptions are Dey Road, Scudders Mill Road, Schalks Crossing Road and Route One. They are maintained and plowed by Middlesex County, except for Route One, which is the responsibility of the New Jersey Department of Transportation.

During a winter storm, the town's Department of Public Works (DPW) starts with clearing the primary roads. Keeping them clear is essential for emergency vehicles to travel through

town. Once clear, DPW staff begins working on residential secondary roads. A storm that is lengthy and/or has heavy accumulation often requires DPW crews to leave the residential roads and return to the primary roads. Once all the roads are clear, DPW staff clears the bus stops and select walkways.

"Snow removal is a challenging operation and DPW staff continues to provide effective and efficient services utilizing available resources. DPW staff continues working until all snow is removed from the streets, which often means, they plow for hours after it stops snowing," stated Township Committeeman David Bander.

Snow and ice removal is not solely the town's responsibility. Residents are required to clear snow and ice from the sidewalks abutting their property within 24 hours of the storm's completion. The snow cannot be placed in the paved portion of any street where it hinders the passage of pedestrians, bicyclists or vehicles. It also requires DPW plows to return and remove the snow.

## Curbside Recycling – What You Need to Know!

In 1987, New Jersey became one of the first states in the nation to mandate recycling by separating glass, paper and plastics into different containers and placing them curbside for collection. Since then, recycling has changed. Now we put everything in one container and place it out for collection. But, are we placing the right items in our bins for collection? Are there consequences for placing non-recycling items in a container? What happens when we don't properly recycle?

A recent observation of recycling containers left curbside for collection indicates that approximately 50% of the containers were 'contaminated' meaning that they contain items that are not recyclable. The number one non-recyclable item found in these containers is plastic bags. Plastic bags are **NOT** recyclable through our curbside program. Most of the contamination occurs when residents placed their recyclable items in plastic bags and then place the plastic bags in the recycling container. Other types of contamination included placing the wrong type of plastic containers in the bin and also dirty containers.

When a recycling container is contaminated the recycling hauler is required to leave the container and the resident becomes responsible for its disposal. If the hauler collects contaminated recyclables or the wrong type of recyclables, it contaminates the entire load making it no longer eligible for recycling. As a result, it becomes garbage and is sent to a landfill—exactly what recycling is trying to prevent.

**Starting January 6, 2020 our recycling hauler will no longer accept contaminated recycling bins. If your recyclables**

**are in plastic bags, your bin will not be collected. If your recycling containers are filled with non-recycling items, that bin will also not be collected.** You are responsible for what's in your recycling container.

# The Role of Class III Special Law Enforcement Officers

**C**lass III Police Officers are retired police officers hired specifically to work within our public schools. Their primary responsibilities are to ensure the safety and security of all students and staff and to become part of the social fabric of the school community. Candidates interested in becoming a Class III officer are required to complete an interview, undergo a thorough background investigation, physical exam and a psychological evaluation. Candidates must then complete a comprehensive four-week training program, including all state-mandated training, prior to beginning his/her duties within the school system.

Eight officers are needed in order to fully staff the five public schools located within Plainsboro's jurisdiction. The Plainsboro Police Department is currently in the process of hiring three

Class III officers to join the five officers that are currently serving our schools.

## Crime Prevention is a Shared Community Endeavor

### Vital Records

The local registrar is responsible for maintaining vital records of births, marriages/civil unions, domestic partnerships and deaths that occurred in Plainsboro Township. The municipality that holds the original record is the only registrar, besides the State Registrar, that can issue a certified copy.

A Certified Copy of a vital record is issued to those individuals who have a direct link to the individual(s) named on the vital record, as identified in the Governor's Executive Order 18, and provided that the requestor is able to identify the vital record and can provide proof of his identity and relationship.

### Pet Licenses

NJ State Law mandates that all dogs six months and older must be licensed annually by the Township. Licenses are due for renewal by January 31st with penalty charges beginning on February 1st. Applications for dogs and cats are available from the Township Clerk's Office and the township website. Failure to license pets is in violation of Plainsboro Township's Ordinance 59-1 and can result in a summons. \*\*According to state regulation N.J.A.C. 8:23A, when licensing, the rabies vaccination immunity must extend through at least ten (10) months of the 12-month licensing period. Licenses cannot be issued if the rabies vaccination expires before November 1st of each year. If for any medical reason the animal cannot be vaccinated in the required time, form VPH-28 must be completed by the veterinarian and submitted with the renewal form.
