

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF
PLAINSBORO, IN THE COUNTY OF MIDDLESEX, STATE OF NEW JERSEY,
PROVIDING FOR THE MUNICIPAL CONSENT OF THE TOWNSHIP FOR
SUEZ WATER NEW JERSEY, INC. TO PROVIDE WASTEWATER SERVICE TO
CERTAIN PROPERTIES WITHIN THE MUNICIPAL BOUNDARY AND FOR
THE LAYING OF PIPES AND INSTALLATION OF OTHER UTILITY
FACILITIES AS MAY BE NECESSARY**

WHEREAS, certain properties identified below located within the Township of Plainsboro (“Township”) have historically utilized on-site private septic system for the disposal of domestic wastewater for developer properties; and

WHEREAS, SUEZ Water New Jersey Inc. (“SUEZ”), is a New Jersey public utility corporation providing wastewater service to certain areas within the Township; and

WHEREAS, SUEZ desires to secure the consent of the Township to (i) provide wastewater service to the aforesaid properties, and (ii) although not currently necessary, to lay sanitary sewer mains beneath public roads, streets and places adjacent thereto as it may deem necessary in the future for its corporate purpose to provide wastewater service to the aforesaid properties; and

WHEREAS, SUEZ and the Township believe that it would be in the best interest of the Township and its citizens to connect to the public wastewater system; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Plainsboro in the County of Middlesex and the State of New Jersey as follows:

Section 1. SUEZ Water New Jersey Inc., is hereby given the consent and permission of the Township of Plainsboro to provide wastewater service to the below referenced properties and to lay, maintain and relay its sanitary sewer mains, pipes, connections, apparatus and appurtenances beneath such public roads, streets and places as it may deem necessary in the future for its corporate purposes, subject to such additional approvals or consents as the law may require, within the lands and premises hereinafter designated and under all public roads, streets, or places abutting same, for the purpose of providing wastewater service to:

a. Those tracts or parcels of land shown on the Tax Map of the Township of Plainsboro and designated as follows:

All Blocks and Lots East of the Amtrak Railroad (Right of Way) and within the SUEZ Water Princeton Meadows sewer service area.

b. The proposed franchise area will match the sewer service area as provided in the attached exhibit.

Section 2. The consent and permission granted by this Ordinance is made expressly subject to the following conditions:

a. If any disturbance of pavement, sidewalk, driveway, or other surfacing of any public street, road, highway, or other public places, is caused by SUEZ, then SUEZ shall, at its own cost and expense and in a manner approved by the Township, reasonably replace and restore the paving, sidewalks, driveways, and other surfaces of any street, road, highway or other public place disturbed, in as good condition as before said work was commenced.

b. SUEZ shall accept this Ordinance in writing within thirty (30) days of its passage.

Section 3. This consent shall take effect upon the approval of the Board of Public Utilities as required by law.
