

**AN ORDINANCE MODIFYING SPEED LIMITS ON GROVERS MILL ROAD  
AND AMENDING SECTION 96-15 OF THE CODE OF THE TOWNSHIP OF  
PLAINSBORO**

**WHEREAS**, in 2019, the Township of Plainsboro was awarded a grant by the New Jersey Department of Transportation to make improvements to Grovers Mill Road; and

**WHEREAS**, Grovers Mill Road contains a tight curve, and, as part of the redesign and improvements being made to the road, it was determined that speed limit adjustments on the road were required; and

**WHEREAS**, pursuant to N.J.S.A. 39:4-197, the Township Committee is empowered to alter speed limits on municipal roadways; and

**WHEREAS**, the Township Committee has determined to amend the speed limits stated in Section 96-15 of the Township Code to ensure the health, safety and welfare of Township residents.

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Plainsboro in the County of Middlesex and the State of New Jersey as follows:

**Section 1**

Section 96-15, "Schedule VI: Speed Limits," of the Code of the Township of Plainsboro shall be amended as follows (deletions are struck through and additions are underlined):

**§ 96-15 Schedule VI: Speed Limits.**

Pursuant to the provisions of § 96-6, speed limits are hereby established upon the following described streets or parts thereof.

**Section 2. Repealer.** All ordinances or parts thereof inconsistent herewith are repealed as to such inconsistencies.

**Section 3. Severability.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**Section 4. Effective date.** This ordinance shall take effect upon its final passage and publication.
