

**AN ORDINANCE TO AMEND CHAPTER 96 OF THE CODE OF THE  
TOWNSHIP OF PLAINSBORO TO APPROVE THE TRAFFIC SIGNAL  
IMPROVEMENTS FOR THE INTERSECTION OF DEY ROAD AND SCOTTS  
CORNER ROAD**

**WHEREAS**, Township Committee of the Township of Plainsboro, Middlesex County, New Jersey, finds it in the interest of public safety to install a Traffic Signal at the intersection of Dey Road and Scotts Corner Road; and

**WHEREAS**, the traffic control signal installation was inspected on October 6, 2022 and completed in accordance with the As-Built Traffic Signal Plan dated October 18, 2022, and Timing Chart dated October 18, 2022; and

**WHEREAS**, it was determined that the traffic control signal installation was designed in accordance with the requirements set forth in the current “Manual on Uniform Traffic Control Devices for Streets and Highways” and that all New Jersey State law requirements have been satisfied; and

**WHEREAS**, the Township Engineer has submitted and certified all of the legislative requirements pursuant to N.J.S.A. 39:4 and N.J.A.C. 16:27; and

**WHEREAS**, Section 96-13.1 entitled “Schedule IVAA: Signalized Intersections” of the Code of the Township of Plainsboro shall be amended to include the traffic signal that has been approved for the intersection of Dey Road and Scotts Corner Road; and

**NOW, THEREFORE, BE IT ORDAINED** that Township Committee of the Township of Plainsboro, County of Middlesex, State of New Jersey believes it is in the best interest of the residents of Plainsboro to approve the installation of the traffic signal for the intersection of Dey Road and Scotts Corner Road.

**Section I:** Amendment to Section 96-13.1 of the Code of the Township of Plainsboro

Section 96-13.1 of the Code of the Township of Plainsboro shall be amended as follows (deletions are ~~struck through~~ and additions are underlined):

§ 96-13.1 Schedule IVAA: SIGNALIZED INTERSECTIONS.

In accordance with the provisions of § 96-25, the following described intersections are hereby designated as signalized intersections:

Intersection
George Davison Road and Plainsboro Road
Plainsboro Road, Wyndhurst Drive and Center Drive [Added 4-14-1993 by Ord. No. 0-93-05]
<u>Dey Road and Scotts Corner Road</u>

**Section II:** That all prior ordinances or resolutions or portions thereof of the Township of Plainsboro inconsistent herewith be and they are hereby repealed.

**Section III:** That this ordinance shall become effective upon adoption and publication as required by law.

**Section IV:** That if any clause, section or provision of this ordinance is declared invalid by a Court of competent jurisdiction, such provision shall be deemed a separate, distinct and independent provision and shall not affect the validity of the remaining portion hereof.
