GRANT OF EASEMENTS

THIS GRANT OF EASEMENTS is made this 6th day
of December, 1985, by WM. FLEMER'S SONS, INC., a New Jersey
corporation, having an office at RD#3, Kingston, New Jersey 08528
(herein called the "Grantor") to THE TRUSTEES OF PRINCETON
UNIVERSITY, a New Jersey corporation, having an office at One
Nassau Hall, Princeton, New Jersey 08544 (herein called the
"Grantee").

WITNESSETH THAT:

WHEREAS, Grantor is the owner of certain land (herein
called the "Grantor's Land") known and designated as Lot 4 in
Block 4, Sheet 2, of the Tax Map of, and situate in, Plainsboro
Township, Middlesex County, New Jersey; and

WHEREAS, Grantee is desirous of obtaining easements
over the Grantor's Land for the purpose of installing, operating
and using storm water collection and drainage pipes, conduits and
other facilities (herein collectively called "Storm Water
Facilities") for the purpose of discharging collected
surface waters into, upon and onto the Grantor's Land; and

WHEREAS, Grantor is willing to grant such easements
upon the terms and conditions herein set forth.

NOW, THEREFORE, in consideration of One Dollar and
other valuable consideration paid by Grantee to Grantor, the

receipt whereof is hereby acknowledged, and of the mutual covenants herein contained, Grantor and Grantee do mutually covenant, promise and agree as follows:

1. Grantor hereby gives and grants unto Grantee the free, perpetual and uninterrupted right, liberty, privilege and easement: (a) to use that portion of the Grantor's Land which is identified as "30 Feet Wide Proposed Drainage Easement" on the plan entitled "Plan Showing Property of William Flemer's Sons, Inc., Plainsboro Township, Middlesex County, New Jersey", prepared by Nassau Surveying Company, Inc., Land Surveyors, Research Park, Princeton, New Jersey, dated March 11, 1985, and last revised November 11, 1985, a copy of which is attached hereto as Exhibit "A" and by this reference made a part hereof, and the center line of which is more particularly described in Exhibit "B" attached hereto and by this reference made a part hereof (herein called the "Easement Area") for the purpose of constructing, installing, operating, using, repairing, replacing, maintaining and inspecting the Storm Water Facilities for the collection, transmission and discharge of collected surface waters from lands now owned by Grantee and located to the west of U.S. Route #1 in Plainsboro Township, Middlesex County, New Jersey (herein called the "Grantee's Land") and the improvements now or hereafter erected thereon;

and (b) to discharge collected and other surface waters from the Grantee's Land, and the improvements now or hereafter erected thereon, through the Easement Area by means of the Storm Water Facilities and into the tributary leading to Heathcote Brook which extends through Grantor's Land and other property of Grantor.

2. Grantee shall have the following additional rights with respect to the rights granted in Section 1(a) hereof with respect to Easement Area: to cut, remove and keep clear, all trees, undergrowth and other natural obstructions growing or located in and upon the Easement Area which may impair, endanger or interfere with the rights herein granted.

3. Grantee covenants and agrees with Grantor that Grantee shall construct the Storm Water Facilities in a good and workmanlike manner, and in accordance with all requirements of governmental authorities having jurisdiction, all at the sole cost and expense of Grantee.

4. If Grantor intends to develop and improve Grantor's Land, then Grantor shall have the right to relocate the Easement Area. If road improvements to the intersection of U.S. Route #1 and College Road West shall necessitate a change in the location of the Easement Area, then Grantee shall have the right to relocate the Easement Area. Any relocation of the Easement Area shall be to the location within Grantor's

Land which is reasonably determined by Grantor and reasonably approved by Grantee and which will not affect the flow of collected surface waters from Grantee's land. Grantor shall not be obliged to incur any expense in connection with the installation of the Storm Water Facilities within the relocated Easement Area.

5. This Grant shall bind and inure to the benefit of Grantor and Grantee, and their respective successors and assigns.

FLEMER'S SONS, INC. SITUATE LYING
AND BEING IN THE TOWNSHIP OF
PLAINSBORO, COUNTY OF MIDDLESEX,
STATE OF NEW JERSEY.

Description of the centerline of a proposed thirty (30) feet wide drainage easement, more particularly described as follows:

BEGINNING at a point in the future proposed northerly right-of-way line of College Road West, one hundred (100) feet in width, said point bearing along said northerly line, South eighty-four degrees, twelve minutes, fifty-five seconds East (S 84° 12' 55" E) three hundred five and seventy hundredths (305.70) feet from the easterly terminus of a curve having a radius of seven hundred sixty-four and twelve hundredths (764.12) feet and from said beginning point running thence;

(1) Through lands of William Flemer's Sons, Inc., North seventeen degrees, thirty-two minutes, zero seconds East (N 17° 32' 00" E) thirteen hundred twenty-one (1321) feet to a point in the centerline of an unnamed tributary to Heathcote Brook, said point being the terminus of the herein described easement.

Containing 0.910 acres.

The sidelines of the above described easement being parallel to and distant fifteen (15) feet as measured at right angles to the above described centerline.

The above described also being known as Part of Lot 4, in Block 4, on Sheet 2, of the Plainsboro Twp. Tax Map.
