**PARTIAL RELEASE AND TERMINATION OF EASEMENT**

**THIS PARTIAL RELEASE AND TERMINATION OF EASEMENT AGREEMENT** (this “Partial Release”) is made as of this 12 day of January 2024, The Trustees of Princeton University, a not-for-profit corporation of the State of New Jersey, with its principal office at One Nassau Hall, Princeton University, Princeton, New Jersey 08544 (“Princeton”).

**BACKGROUND:**

A. Pursuant to that certain Deed granted by Sarah R. May, as grantor, in favor of WM. Flemer’s Sons, Inc., as grantee, on February 6, 1957, and recorded in the office of the Middlesex County Clerk on April 2, 1957, in Deed Book 1956, Page 483 (the “Deed”), rights to a twenty (20) foot wide driveway were reserved (the “Easement”) over property now designated on the tax map of the Township of South Brunswick as Lot 3.113 Block 99 (the “Burdened Property”), for the benefit of property owned in fee simple by Princeton and now designated on the tax map of the Township of South Brunswick as Lot 14.01 Block 99 (the “Benefited Property”).

B. The Easement was granted in connection with a life estate interest in a dwelling house that existed on the Benefited Property at the time of the Deed in order to provide the dwelling house access to the public right of way now known as Greenwood Avenue.

C. The party that was entitled to the life estate interest in the Easement is now deceased, the dwelling house no longer exists, and the Benefited Property has other means of access to a public right of way.

C. Princeton is the current fee title owner of the Benefited Property, and as such is the successor to the beneficial interest in the Easement.

D. Princeton desires to enter into this Partial Release in order to partially terminate that portion of the Easement described on **Exhibit A** attached hereto (“Termination Area”). For purposes of clarity, the Termination Area is the portion of the Easement located within Block 99, Lot 14.04 as shown on **Exhibit A**.

**NOW, THEREFORE**, in consideration of the recitals, which are incorporated herein by reference, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Princeton hereby declares as follows:


1. **Incorporation of Recitals.** The foregoing recitals are hereby incorporated into and made part of this Partial Release as if fully set forth at length herein

2. **Partial Release.** Princeton on behalf of itself and its successors and assigns, hereby terminates, releases and relinquishes any interest that Princeton and its successors and assigns have in and to that portion of the Easement located within the Termination Area.
3. **Partial Termination.** The Easement is hereby partially terminated and discharged of record and is of no further force and effect as to the Termination Area.
4. **Successors and Assigns.** The terms, conditions and provisions of this Partial Release shall be binding upon the successors and assigns of the parties hereto.
5. **Governing Law.** This Partial Release shall be governed by and construed in accordance with the laws of the State of New Jersey.
6. **Miscellaneous.** If any provision of this Partial Release shall be invalid or unenforceable, the remainder of this Partial Release shall not be affected thereby. The headings are for convenience of reference only and shall not limit or otherwise affect the meaning hereof.


