**The Cable Television Advisory Committee-** Established by resolution 04-228 adopted September 8, 2004, advises the Township Committee on matters related to the franchise agreement with Comcast Cablevision, Inc. which may include the review of the rate structure, programming and local origination programming. Members serve three year terms. Meetings are held on an as needed basis.

**Environmental Advisory Committee-** Established by resolution 85-110 adopted June 10, 1985, advises the municipal boards in such areas as use of open space, water resource management, soil control, noise control, recycling, air quality and other environmental concerns. Members serve three year terms. Meetings are held every 4<sup>th</sup> Monday at 7:30 p.m. in the Municipal building.

**Human Relations Council-** Established by ordinance 94-10 adopted August 10, 1994, develops programs and approaches to establish community awareness, understanding and appreciation of our rich ethnic population mix. Members serve three year terms and alternate and teen representatives serve one year terms. Meetings are held every 2<sup>nd</sup> Thursday at 7:30 p.m. in the municipal building community room D.

**Library Board of Trustees-** Determines policy, secures funds and manages expenditures to insure the best possible library service. Within the framework of New Jersey Laws, and personal talents and abilities, there are boundless opportunities to be creative, progressive and responsive to community's lifelong learning needs. Meetings are held every 1<sup>st</sup> Tuesday at 7:30 p.m. in the Library.

**Planning Board-** Established by ordinance adopted December 30, 1976, amended by ordinance 79-07 adopted May 1, 1979 and amended by ordinance 80-6 adopted June 9, 1980, reviews applications for development reviews and adopts Township Master Plan and reviews zoning ordinance changes for the Township Committee. Members serve four year terms and alternates serve two year terms. Meetings are held every 1st and 3rd Monday at 7:30 p.m. in the Municipal Building.

**Shade Tree Advisory Committee-** Established by resolution adopted July 9, 1979, amended by resolution 80-28 adopted February 11, 1980 then amended by resolution 00-54 adopted March 8, 2000, advises the Township Committee and Planning Board on matters related to plantings on public properties, shade trees, landscaping. Members serve three year terms. Meetings are held at 7:30 pm, the 2<sup>nd</sup> Monday of each month. Except for June when the meeting is typically held at 7:00 pm and during the months of July, August & December when there are no meetings.

**Zoning Board of Adjustment-** Established by ordinance adopted December 30, 1976, amended by ordinance 79-07 adopted May 1, 1979 then amended by ordinance 80-6 adopted June 9, 1980, hears appeals for variation from zoning ordinance and occasionally reviews applications for development. Members serve four year terms and alternates serve two year terms. Meeting are held at 7:30 pm, the 1<sup>st</sup> Wednesday of each month in the Municipal Building except when noted.
