

**AN ORDINANCE AMENDING THE SALARY AND WAGE PLAN
FOR THE TOWNSHIP OF PLAINSBORO, COUNTY OF MIDDLESEX,
STATE OF NEW JERSEY FOR NON-UNION EMPLOYEES
AND OFFICIALS FOR 2017 - 2019**

BE IT ORDAINED by the Township Committee of the Township of Plainsboro, County of Middlesex, State of New Jersey, that the salary and wage plan for non-union employees and officials of the Township of Plainsboro for 2017 - 2019 be as shown in the attached document; and that the Township Administrator be authorized to establish the salary for each employee within the specified salary range subject to amounts provided in the budget for 2017 - 2019, and the Township Administrator shall provide to the Township Committee for their information a listing of the salary of each employee. The Administrator of the salary and wage plan established by this Ordinance shall be the responsibility of the Township Administrator.

This Ordinance shall become effective upon adoption after publication thereof in accordance with the law.
